Waiver of Liability (Read and sign below)

1. Release & Waiver. Volunteer and/or Guardian do hereby release and forever discharge and hold harmless Timber Lane Utility District, its officers and directors ("Timber Lane"), as well as its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's activities with Timber Lane, the Community Hike and Bike Trails Program or any other Timber Lane Community Service Project. Volunteer & Guardian understand that this Release discharges Timber Lane from any liability or claim that the Volunteer and/or Guardian may have against Timber Lane with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's activities with Timber Lane, whether caused by the negligence of Timber Lane or its officers, directors, employees, or agents or otherwise. Volunteer and/or Guardian also understand that Timber Lane does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

2. Consent to Medical Treatment. Should an Emergency Situation arise that necessitates medical or surgical attention, I hereby give my consent and permission to Timber Lane Utility District, its directors and representatives to act on my behalf in authorizing medical, dental, surgical care or hospitalization for the above named Volunteer, and I further authorize any attending physician(s) to make such decisions and to perform such medical treatment(s) and/or surgical procedure(s) and/or hospitalization upon and for the above named Volunteer, which may, in the professional opinion of the attending physician, be necessary and proper under the circumstances of any Emergency Situation. Volunteer and/or Guardian do hereby release and forever discharge Timber Lane from any claim whatsoever which arises or may hereafter arise on account of any first aid, medical treatment, or service rendered in connection with the Volunteer's activities with Timber Lane or with the decision by any representative or agent of Timber Lane to exercise the power to consent to medical or dental treatment.

3. Assumption of Risk. The Volunteer and/or Guardian understand that the activities may include work that may be hazardous to the Volunteer, including, but not limited to, construction, tools, equipment, construction materials and transportation to and from the work sites. Volunteer and/or Guardian hereby expressly and specifically assume the risk of injury or harm in the activities and release Timber Lane from all liability for injury, illness, death, or property damage resulting from the activities.

4. Insurance. The Volunteer and/or Guardian understand that, except as otherwise agreed to by Timber Lane in writing. Timber Lane does not carry or maintain health, medical, or disability insurance coverage for any Volunteer. Each volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.

5. Photographic Release. Volunteer and/or Guardian do hereby grant and convey unto Timber Lane all right, title, and interest in any and all photographic images and video or audio recordings made by or on behalf of Timber Lane during the Volunteer's activities with Timber Lane, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings. Volunteer and/or Guardian further release Timber Lane from any liability for the use of such photographic, video, or audio recordings.

6. Other. Volunteer and/or Guardian expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Texas and that this Release shall be governed by and interpreted in accordance with the laws of the State of Texas. Volunteer and/or Guardian agree that in the event that any clause or provision of this release is found to be legally insufficient, all other clauses and provisions shall remain in effect and shall continue to be enforceable.
