Applicant agrees to indemnify and hold harmless Timber Lane Utility District, its officers and agents against any and all claims, demands, or causes of action which may arise out of or result from the use of the facilities described in this Application for Use for Special Event, including, but not limited to those claims, demands, and causes of action involving personal injury, death or property damage.

Applicant understands that alcoholic beverages are prohibited in the Timber Lane Ciderwood Building, Timber Lane Park, Liberty Park, Sandpiper Park, Cypress Creek Park, Herman Little Park, and all District Recreation Areas. Applicant will forfeit the deposit and the remaining reservation time if anyone at the Special Event is found with alcoholic beverages.
